### GUIDELINES REGARDING THE CRITERIA FOR METU FACULTY MEMBER APPOINTMENT AND PROMOTION

All candidates applying for a faculty member positions at Middle East Technical University (METU) are required to have met the criteria for the relevant title as specified in the Rules and Regulations for Promotion and Appointment of Faculty Members. In addition to the Regulations, candidates are also expected to meet the METU Faculty Member Appointment and Promotion Criteria. These criteria for appointment and promotion specify the minimum requirements for being able to apply for the positions. While fulfilling these requirements is a prerequisite for promotion and appointment, they may not be found sufficient. The essential step is the evaluation of the jury. In the jury reports, the candidate's works and studies are evaluated in terms of their content.

Candidates applying to start working at the faculties or graduate schools of METU for the first time as a faculty member must meet the requirements below in addition to the new promotion and appointment criteria:

A) A doctoral degree from a recognized university abroad (the university must be among the top 700 universities worldwide according to the Times Higher Education [THE] or QS World University Rankings [QS] or the department/faculty graduated from must be among the top 250 in its field worldwide) or,

B) If the criteria of Article A are not met or if the candidate has a doctoral degree from a university in Turkey, they are required to have taken part in person in the “academic production processes” of a reputable university or an independent research institute abroad (the university or institute needs to rank among the top 700 universities worldwide according to the Times Higher Education [THE] or QS World University Rankings [QS]) for at least two semesters (9 months) . The academic output of these studies needs to be approved by the Presidency, following the positive evaluation by the relevant faculty's Human Resources Commission and the recommendation of the Faculty Administrative Board (in graduate schools, following the recommendation by the Graduate School Administrative Board).

In addition to the evaluation process specified by the laws, all candidates applying for a faculty position are required to conduct in English a demo lesson or a seminar focusing on their academic studies, in order to assess their teaching and research abilities. The demo lesson or seminar must fall within the scope of the department / program applied to and must be found successful by the Academic Board.

All candidates, irrespective of whether they received their doctoral degrees from a university in Turkey or abroad, are also expected to meet the following criteria:

i) Considering the faculty member requirement / recruitment plans approved by the faculties or the graduate schools to which the departments are affiliated, the strengths and competence of the candidates within their field must be evaluated on the basis of concrete criteria.

ii) It is expected that the ratio of faculty members with doctoral degrees from relevant departments of faculties or graduate schools in Turkey (including METU) does not exceed 50% of the faculty members in the department or program applied to. However, in cases of difficulties in recruiting candidates who received their doctoral degrees abroad, this ratio can be increased up to 60% with the approval of the Presidency after the proposal of the Graduate School Administrative Board in graduate schools or the proposal of the Faculty Administrative Boards and the reasoned affirmative opinion stated by the Faculty Human Resources Commission in faculties. This article is valid for departments with 5 or more faculty members. After the new criteria come into force, departments

where the ratio is higher than what is mentioned above will appoint new faculty members with doctoral degrees from universities abroad.

iii) Candidates who will work as a faculty member in a faculty or graduate school at METU for the first time must meet the following conditions (excluding native English speakers and the ones who continue working in the position where they were appointed before as a faculty member at METU by meeting the conditions specified below):

- Having the minimum score accepted by the METU Senate and approved by the Council of Higher Education (YÖK) from the Foreign Language Placement Test (YDS), Higher Education Council in Interuniversity Council Foreign Language Exam (ÜDS), Public Personnel Foreign Language Proficiency Exam (KPDS), or Council of Higher Education Foreign Language Exam (YÖKDİL); or obtain an equivalent score from a foreign language exam approved by the Measuring, Selection and Placement Center (ÖSYM).
- The faculty member candidates who meet the conditions for application are take an oral interview in English with the conditions specified by the METU Senate.

### **COMMON PRACTICES REGARDING THE CANDIDATES WHO WILL WORK AS FACULTY MEMBERS IN FACULTIES OR GRADUATE SCHOOLS**

- 1- The New Appointment and Promotion Criteria (AYK) will be valid as of April 21, 2021, the date of their approval by the Senate. For faculty members who were appointed to their position as Assistant Professor or Associate Professor before April 21, 2021, and who are working full-time at our University, the faculty members' request will be taken into consideration regarding whether they will be evaluated according to the old or new criteria in the next promotion stage. For faculty members appointed to their positions as Assistant Professor and Associate Professor after the aforementioned date, the new appointment and promotion criteria approved by the Higher Education Council will be applied in the next promotion phase.
- 2- According to the new appointment and promotion criteria, while the scientific activities of the candidates who work as faculty members at our university and apply for the position of Professorship are evaluated, their publications and other works which were previously used for applying for the position of Associate Professor cannot be used again. **Only the publications and other works of the candidate after the application date** upon fulfilling the requirements for appointment to the position of Associate Professor are evaluated for the position of Professorship.

The candidates who apply to be appointed as Professor must have fulfilled the requirements specified in the “Activity-4” section after starting their academic career as a faculty member.

- 3- Regarding applications to Assistant Professor positions, if the candidate applies 4 years after receiving their doctoral degree, they are required to have published one full article from Group 1A or a national/international book or book chapter for every 2 years following the 4 years after receiving the degree (the total number of publications at the end of the relevant period is evaluated for this criterion).
- 4- For the project criteria required for applications to Professor positions, the project process must start after the candidate's application to Associate Professor position, and the duration of the research project must meet the minimum requirements specified below:

- 5- While applying for any position, the publications submitted must either be published or have a DOI (Digital Object Identified) number. While applying for any position, publications submitted during the application stage that will be evaluated within the scope of Web of Science (WoS) must be indexed in SCI, SSCI, SCI-E, or AHCI journals.
- 6- If the Q ranking of a journal is different at the time of an article's publication from when the article was sent for publication by the candidate, or if a journal is listed in multiple categories, the highest category of Q ranking will be accepted for evaluation.
- 7- After the criteria are set, the academic boards of the departments affiliated to faculties and graduate schools list the most prestigious 20 conferences (40 conferences for departments with more than 20 faculty members) among international peer-reviewed conferences and submit them to the Presidency. (These conferences are announced on <https://pdb.metu.edu.tr/ogretim-uyesi-atama-ve-yukselme-kriterleri> each year starting from January). In order for the papers orally presented in international peer-reviewed conferences to be considered as valid for promotions and appointments, the conference must be listed among the ones selected by the academic boards of the departments affiliated to faculties and graduate schools. The aforementioned conference lists may be updated every year in January by the academic boards of departments affiliated to faculties and graduate schools if necessary.
- 8- The international field indexes suggested by the departments of graduate schools or the departmental academic boards of faculties, together with the faculty / graduate school decisions on the lists of national / international publishers for books, are submitted to the University Administrative Board for their approval. In order for those academic activities to be considered as valid for promotions and appointments, they must be listed among the ones approved by the Senate. The aforementioned index lists may be updated every two years in January by the University Academic Board if necessary.
